Interpretation

'Privacy Policy' means the privacy statement displayed on the Website.

'Product' or 'Products' means Luxury Day Tours or Vouchers available on the Website.

'TT' means The Tailor Pty Ltd ACN 068 690 700

'TT LDT' means TT's Luxury Day Tours

'Supplier' or 'Suppliers' means third party providers and operators of luxury day tours or travel engaged by TT to provide Luxury Day Tours or other Products or services offered on the Website.

'Voucher' means the online voucher, gift voucher or gift certificate purchased via the <u>www.rmfootsteps.com.au</u> Website for a specified Luxury Day Tour or for a specified monetary amount redeemable for, or towards the price of, a Luxury Day Tour selected by the recipient of the Voucher.

'We', 'Us' or 'Our' means and is a reference to TT.

'Website' means the TT and the **www.rmfootsteps.com.au** Website that enables users to research, find and Book Products.

'You' means the Client as a party to this Agreement.

- 1.2 The terms Booking, Client and Supplier will have the same meaning as in Our Privacy Policy.
- 1.3 TT in conjunction with selected Suppliers offers various Luxury Day Tour experiences. Bookings are subject to the Suppliers' terms and conditions. Refer to clause 9.
- We reserve the right to change or modify all or any 1.4 part of these terms and conditions, without changes to posting notice. by the www.rmfootsteps.com.au Website. Any amendments to these terms and conditions take effect immediately upon posting to the www.rmfootsteps.com.au Website. The terms and conditions that form this Agreement are those that are current at the time that You make a Booking.
- 1.5 This Agreement applies to all Products and available services on the www.rmfootsteps.com.au Website and applies to Bookings made on the Website whether made online, through any mobile or tablet device, by using telephone. Bv email or the www.rmfootsteps.com.au Website or any other means referred to in this clause, to make a Booking You acknowledge and represent that You have read, understood and agreed to the terms and conditions in this Agreement.
- 1.6 By making a Booking through the www.rmfootsteps.com.au Website you warrant that you are at least 18 years old and able to enter legally binding obligations.
- 1.7 The term "via the <u>www.rmfootsteps.com.au</u> Website" includes making any transaction in respect of a Product available on the <u>www.rmfootsteps.com.au</u> Website if made by any other means permitted by TT in accordance with this Agreement, including but not limited to, Bookings made by telephone or email.
- 1.8 All prices are quoted in Australian dollars unless otherwise specified. Payments must be made in the currency quoted. TT reserves the right to adjust prices quoted in currencies other than Australian dollars to reflect fluctuations in foreign exchange rates or tariff markets. All prices are GST inclusive unless specifically stated to be GST exclusive.

2. Making a Booking

- 2.1 You can make a Booking direct on the Website or by contacting <u>www.rmfootsteps.com.au</u> Customer Service Centre by telephone or email.
- 2.2 You agree to make a full payment for the Tour at the time of making a Booking. Payment can only be made via a debit to your nominated credit card, debit card or other payment method offered on the payment section of the www.rmfootsteps.com.au Website.

- 2.3 The total amount that You will need to pay for your Booking will be shown to You prior to Your accepting the terms and conditions of this Agreement and pressing the Pay Now or Book Now button on the <u>www.rmfootsteps.com.au</u> Website.
- 2.4 TT <u>www.rmfootsteps.com.au</u> reserves the right to withdraw, change, cancel or reallocate the Tour components, the tour cost and the departure date at its discretion at any time before the Booking is confirmed. However, if such changes are made We will provide You with the option to accept the altered Tour components or to cancel the Booking and receive a full refund.
- 2.5 Any variation requested by You to a Tour Booking must be made in writing to www.rmfootsteps.com.au. We may, in our sole discretion, decide whether to accept a request for variation. We reserve the right to charge an administration fee of up to \$100 per person per variation. The Client must pay any extra cost arising from the variation including any applicable cancellation fees incurred by www.rmfootsteps.com.au from Suppliers, and the administration immediately. fee. www.rmfootsteps.com.au reserves the right to immediately pass the surcharge on to you via your nominated payment method as set out in clause 2.2 without notice

3. Contact Details Given to Luxury Day Tour Suppliers

3.1 It is Your responsibility to ensure you enter Your email address and other contact details correctly when you complete the Booking on the <u>www.rmfootsteps.com.au</u> Website. Failure to do so may result in loss or incorrect delivery of the email confirmation of your Tour. 4. Prices, Payment, Surcharges

4.1 www.rmfootsteps.com.au will use all reasonable efforts to maintain the Tour cost as quoted at the time of Booking. We will notify Clients in writing as soon as We are aware of any likely surcharge. If the surcharge is not paid within the time stipulated on the invoice, We may, in Our discretion, construe such non-payment as a cancellation by You and the provisions of the cancellation clause will apply.

5. Cancellations and Refunds

5.1 If a <u>www.rmfootsteps.com.au</u> needs to cancel a Luxury Day Tour for any reason, you will be notified as soon as possible in order to reschedule a convenient alternative date. If an alternate date cannot be arranged or agreed, then you will receive a refund.

- 5.2 If refund deemed appropriate, the refund excludes any delivery or transaction fees paid at the time of purchase. Only the purchaser is entitled to a refund.
- 5.3 The Client must notify <u>www.rmfootsteps.com.au</u> in writing if it wishes to cancel any Booking and will be effective only upon written acknowledgement by <u>www.rmfootsteps.com.au</u> Customer Service Centre. Refunds for cancellations are subject to the deduction of the applicable cancellation fee set out below.

- 5.8 No refunds are payable to the Client for any changes to the Tour requested by the Client after departure, the Client's failure to appear for the Tour or any component part of the Tour, the Client leaving the Tour after its commencement, the Client being excluded from the Tour or any component part of the Tour in accordance with this Agreement.

6. Expiry and Extensions of Vouchers

- Vouchers are non-refundable and a Tour must be 6.1 Booked and taken within 12 months of purchase. Voucher has expired Once а www.rmfootsteps.com.au is under no obligation to offer an extension; however, We will assess requests for an extension of the Voucher expiry date on a case-by-case basis. Extension requests are reviewed by Our Customer Experience Team via email at CONTACT US on the Website. Any request for an extension of a Voucher that is over 1 month past the expiry date will not be considered.
- 6.2 Any unused value of an expired Voucher will become the property of www.rmfootsteps.com.au.

7. **Complaints/Dispute Resolution**

- 7.1 Clients should immediately notify the Supplier of any complaints so that issues may be addressed on the spot where possible.

- 10.4 Without in any way limiting the operation of the release in the above clause, the Client hereby releases TT from all actions, proceedings, claims or demands that the Client may have now or in the future against TT under the *Competition and Consumer Act 2010* (Cth) (Act) for death or personal injury (as that term is defined in the Act) that the Client may suffer or incur, whether directly or indirectly, as a result of any failure of TT to provide services with due care or skill.
- 10.5 The Client will be responsible for any loss or damage arising from their own acts or omissions.
- 10.6 TT <u>www.rmfootsteps.com.au</u> does not make any express warranties in relation to the Luxury Day Tour, and TT <u>www.rmfootsteps.com.au</u> hereby excludes all implied conditions and warranties, except any implied condition or warranty the exclusion of which would contravene any statute or cause this clause to be void (**Non-Excludable Condition**).
